Notice of Enforcement Order Closure
Enforcement Order Number DC-110829-1, issued August 29, 2011

Mr. Mauerman:

On August 29, 2011, the Colorado Department of Public Health and Environment, Water Quality Control Division (the "Department") issued Enforcement Order, Number DC-110829-1 (the "Order") to the Registered Agent for the Meadow Mountain Water Supply Co. public water system. The Order was issued as a result of the Registered Agent's failure to comply with the requirements of 5 CCR 1002-11, the Colorado Primary Drinking Water Regulations ("Regulation 11"), as they relate to the operation of the Meadow Mountain Water Supply Co. public water system.

The Department acknowledges that the Registered Agent has fully responded to and met the obligations pursuant to the Order. Therefore, the Department is hereby closing Enforcement Order Number DC-110829-1, and no further action is required from the Registered Agent with regards to this Order.

Please be advised that the Registered Agent has an ongoing obligation for compliance with the Regulation 11, and that future non-compliance may result in additional enforcement activity that may include the assessment of administrative or civil penalties. Additionally, the Registered Agent has an ongoing obligation, pursuant to 25-9-110(2)(a), C.R.S., to ensure that the Meadow Mountain Water Supply Co. public water system is under the responsible charge of a certified operator who is certified at a level consistent with Meadow Mountain Water Supply Co.'s classification level.
