Subject: Compliance Advisory – Monitoring and Reporting Requirements, Chlorine  
Residual

Dear Ms. BARKWORTH:

According to the Water Quality Control Division's (the "Division") records, the MEADOW MOUNTAIN WS was required to monitor for chlorine residual in compliance period of third quarter 2008, in the distribution system at the same time and location as total coliform bacteria are sampled. The *Colorado Primary Drinking Water Regulations* (the "Regulations") require that public water systems report the results of any required test measurements or analysis within either the first ten days following the month in which the result is received, or within the first ten calendar days following the end of the required monitoring period. To date, results of this required analysis have not been received at the Division.

The Division prefers that these results be reported with each total coliform sample result. However, if the required monitoring was performed but not submitted with the total coliform sample results, the results must be submitted to the Division using the "Quarterly Reporting Form for Chlorine and Chloramines Maximum Residual Disinfectant Level Running Annual Average" (MRDL Form 2). Submitting is encouraged to be done via electronic mail to [cdphe.drinkingwater@state.co.us](mailto:cdphe.drinkingwater@state.co.us). Submitted documents need to be in PDF format and signed. Submitting in this manner provides both the MEADOW MOUNTAIN WS and the Division electronic record of receipt.
